The first groups will start measuring soon. Before monitoring can start, a site selection proposal has to be sent to IRAS. ESCAPE exposure assessment manual

The ESCAPE exposure assessment manual has been sent to the groups who did monitoring in the first year. It can also be found on the ESCAPE website. This manual provides procedures for exposure assessment within ESCAPE that are not covered in the overall study manual. The ESCAPE exposure assessment manual explains modelling issues: GIS data, modeling procedures, validation, and extrapolation of exposure back in time.

It is important that the groups that measured in the first year start collecting GIS data as soon as possible. Collection of GIS data should be finished in February 2010. Please read this ESCAPE exposure assessment manual carefully for procedures and deadlines.

GIS analyses and LUR workshop 2010

A workshop on GIS analyses and LUR modelling analyses for the groups that measured in the first year has been planned for April 2010. During the workshop there will be explanation of GIS analyses, doing own GIS analyses and LUR model development with own data.



Geocoding of addresses of study participants

Geocoding of addresses of study participants is an important step in the exposure assessment process. The addresses should be made available by the individual studies within the Health WPs. If needed geocoding can be conducted by the groups that will do the GIS analyses. An ESCAPE geocoding manual can be found at the ESCAPE website. A description of the different steps in exposure assessment and who is responsible for which step, can be found in the ESCAPE exposure assessment manual (see ESCAPE website).

ESCAPE related projects

TRANSPHORM

TRANSPHORM is a project on health impacts of transport related air pollution that is now in the negotiation phase. ESCAPE WP lead institutes are integrated in this study, which will support a fair amount of additional exposure measurements and modelling for the ESCAPE cohorts

CONCAWE

CONCAWE has decided to fund a validation study, in which we will be doing personal exposure measurements in three ESCAPE areas (Utrecht, Barcelona and Helsinki) to validate the exposure models we're building for ESCAPE.
